

TERMS AND CONDITION

\$5 NO DEPOSIT BONUS PROMOTION

1. The \$5 No Deposit Bonus Promotion (the "FREE USD 5 (Pro)" or "Account") is organised by Saracen Inc (hereinafter the "Company").
2. The promotion is available ONLY to new account holders. Existing account holders are not permitted to participate in this promotion.
3. Account holders must be of 18 years of age and/or above.
4. Account holders must be citizen of Malaysia ONLY. Allocation for Indonesia, Vietnam and Thailand has been ended.
5. To be eligible to receive the \$5 Free Account, the participant must first obtain a new fully approved account.
6. The \$5 credited into the Account, by the Company, are in the form of non-withdrawable, non-transferable trading credit (the "Trading credit" or "Credit") and valid for a period of 90 days from the date the credit was granted.
7. To withdraw any profits generated in the FREE USD 5(PRO) Account, the Client must satisfy the following conditions:
 - a) Profits are equal to or higher than \$25 and traded at least 2 standard lots. Only \$25 can be withdraw. Any withdrawal request contrary to the above will automatically result in cancellation of the \$5 trading credit.
 - b) Only trades on currencies (Forex) and commodities shall be calculated.
